

## Message #5 from the Nomination & Election Committee (NEC)

Dear Devotees

Absentee ballots were mailed out on 11/03/18. You should be receiving the ballots within the next few days.

The package sent to you had an instruction sheet, ballots and **one** stamped, self-addressed envelope. If you are a family member and had requested 2 ballots, you should have received 2 ballots. Some family members requested only one ballot. Anyone with individual membership was mailed only one ballot.

Please read the following points carefully.

- 1) Each return envelope has a unique identifier specific to the package that was mailed. It is important that you return the ballots only in the envelope provided with the unique identifier. Any ballots mailed in a different envelope will be disqualified.
- 2) All members are requested to return the ballots by mail and not wait till Election Day to drop the ballots in person. The ballots will be invalidated unless the return envelope with the unique identifier is used.
- 3) Please make sure that your choices are properly marked and you make no more than 5 choices. Any overlap or any more than 5 choices will invalidate the ballot.
- 4) If you have not received the absentee ballot package before the 10<sup>th</sup> of November, please send the NEC a note. The NEC will decide on the path forward.
- 5) The NEC will be collecting the returned envelopes every few days from the PO Box. These envelopes will be cross referenced with the unique identification number.
- 6) All envelopes will be opened the day of the election during counting to maintain confidentiality.

We ask all the BOT nominees to send us a one page synopsis explaining why the General Body members should elect them by November 8<sup>th</sup> and they will be included in the future temple and HCC bulletins.

Dear Devotees

The nomination withdrawal deadline is now over and we have a revised list based on the latest updates. One candidate withdrew his nomination from both BOG and BOT. As we indicated in our earlier messages, there are five BOT vacancies for three years each; two BOD vacancies for three years each and two BOG vacancies for three year each. Dear Devotees

Hope you all had a wonderful Dusserra and are now looking forward to Diwali.

The nomination deadline is over and we have received few nominations both via email and handed over in person. No nominations were mailed to the PO Box address.

As we indicated in our earlier messages, there are five BOT vacancies for three years each; two BOD vacancies for three years each and two BOG vacancies for three years each.

You can also submit your nomination form in the main temple in person to a NEC member on the following dates mentioned below. Please note that in light of past experiences we request you not to drop the nomination form in the hundi. It is important that you bring photo ID to enable you to cast your vote. In the absence of a photo ID, the NEC may ask two voters with photo IDs to certify your identity.

### **Note on filing nomination**

Nominations could be filed one of 3 ways.

- Scanned nominations could be emailed to the NEC member.

Please note that nominations can **no longer be dropped in the Hundi** as was the practice in past years.

The nomination form has to be filled in completely to avoid any confusion.
