Background

- New York Senate Bill S6648 passed on July 21, 2020
- Current status of the bill
 - √ Has moved to New York Assembly for consideration as A8545
 - ✓ With Education Committee of New York General Assembly
- Requires grade 6-12 curricula to incorporate Symbols of Hate
- Explicitly calls out two specific symbols of Hate:
 - Swastika
 - Noose
- Mandates teaching Swastika as an emblem of Nazi Germany for 6 continuous years of instruction

Hindu-Americans are aware and empathetic

- Increased expressions of hate against Jewish and African Americans
- Disturbing Nazi Graffiti scrawled outside properties
- Goal of perpetrators is to instill fear and intimidation

 We applaud the intent and spirit of the Bill to address challenges of anti-Semitism and racism via education

Issues with Bill

- Demonizes the sacred Swastika
 - Does not distinguish the sacred Swastika from the Hakenkreuz (Hooked Cross)

 Misattribution of the Hooked Cross as the Swastika should not negate 1000s of years of religious faith and tradition

- Proposed legislation without nuance and adequate safeguards
 - May deny people of Indic religions their right to religious freedom
 - Kids of Indic faiths could become targets of hate and bullying
 - Undermine the rights of parents of Indic faith from teaching their children their religion, symbols, traditions and values

The Swastika--a sacred spiritual symbol of 3 Indic Faiths for millenia



- Buddhism, Jainism & Hinduism, which represent at least 1/5th of humanity
- Native Americans (e.g., Navajo, Hopi), Africans (Akan, Ashanti from Ghana), ...
- Sanskrit meaning Su + Asti = Well + Being denotes Wellness for All
- Connotes sanctity, auspiciousness, good luck, well-being, insight, eternity, and the sublime is a spiritual symbol with multifaceted meanings
- Ubiquitous use by millions for consecration, inspiration and spiritual well-being
 - ➤ e.g., home-threshold drawings, pendants, altars, home exteriors, vehicle decoration, entrances of businesses, doors, tattoos, rituals, ...

• The Swastika is <u>clearly distinct</u> from the Hakenkreuz

 The Hooked-Cross has been <u>incorrectly associated</u> with the Swastika

Hijacked by the National Socialists (Nazis) in 1920

Hindu-Jewish Leadership Summit Declaration


Recognizes

- > The sanctity of Swastika for Hindus for millennia
- Distortion and misappropriation by the Nazis

"The Svastika is an ancient and greatly auspicious symbol of the Hindu tradition. It is inscribed on Hindu temples, ritual altars, entrances, and even account books. A distorted version of this sacred symbol was misappropriated by the Third Reich in Germany, and abused as an emblem under which heinous crimes were perpetrated against humanity, particularly the Jewish people. The participants recognize that this symbol is, and has been sacred to Hindus for millennia, long before its misappropriation."

Solutions

Designate the Hakenkreuz (the Hooked Cross) as the hate symbol

- Educate grade 6-12 students that
 - > the Hakenkreuz is not the sacred Swastika
 - > the Swastika is a sacred symbol across multiple cultures for millenia
 - > the Hakenkreuz was mis-associated with the Swastika, and misused for hate crimes

- Include adequate safeguards for the sacred Swastika and its multifarious uses
 - > Religious, cultural, artistic, aesthetic, spiritual, mundane, mathematical, ...
